Access to the Courthouse shall continue to be limited to authorized personnel until further notice.

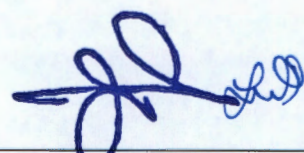

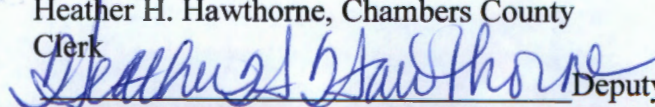
